





EXPRESSION OF INTEREST (EOI)

Puntland Highway Authority (PHA) is mandated with planning, designing, constructing, implementing and maintaining roads throughout Puntland. It is thus imperative for Puntland Highway Authority to be in a stronger position to address challenges posed by a road network dilapidated by years of conflict in the country.

Puntland government is now focused on development-based initiative that aims to improve the state of economic infrastructure. Therefore, the chief aim of Puntland Highway Authority, which secures funds from fuel levy and international partners, is to develop, formulate and implement roadway construction and rehabilitation programs. PHA is also a viable entity with the basic required structure for planning, design, road safety and execution of construction as well as maintenance projects.

The European Union (EU), the German Federal Ministry for Economic Cooperation and Development (BMZ), Puntland State of Somalia and GIZ – Sustainable Road Maintenance Project have made available funds meant for road rehabilitation and maintenance in Puntland State of Somalia.

Puntland Highway Authority (PHA) thereby invites eligible firms to indicate their interest in carrying out road construction and maintenance works on an 80km section of the Bosasso – Galkacyo corridor from Jalam to Xarfo (Puntland State of Somalia). More specifically, the Firm will carry out the following services:

- 1. Repairing/Improvements of existing culverts and construction of new culverts.
- 2. Construct access culverts.
- 3. Earthwork, Sub Base and Base activities.
- 4. Single surface dressing approx. 30km, double surface approx. 50km and road surface marking approx. 80km.
- 5. Construct and install road traffic signs.











Interested Firms must provide information indicating that they are qualified to perform the services by providing description of similar assignments and appropriate skills. The Firm must indicate in their bid the specific qualified staff with the requisite qualifications to perform the services. The Firm must provide the following:

- a) Copies of certificate of incorporation / registration for local firms.
- b) Copy of registration license of the company.
- c) Tax compliance certificate From Puntland Ministry of Finance.
- d) Capability to perform the services: Company Profile, Brochures, description of assignment and experience in similar projects e.g. provide reference letters.
- e) CV's of the respective technical staff and professional references.
- f) Document with contact details of company (address/email/phone)
- g) List of construction equipment's to be deployed i.e. Make and Type, Year of Manufacture, Capacity, Ownership and number to be deployed.
- h) Proof of financial capability i.e. Financial volume of construction works carried out for the last three years and balance sheets for the last three years

Eligible Firms should submit their "Expressions of Interest" clearly marked (Road Rehabilitation Jalam - Xarfo) in plain sealed envelopes in the Tender Box situated at the PHA Offices, Garowe not later than 20th September 2016 @1600hrs (East African Time).
